- Complete the PVET Expression of Interest form on the fmpllen website and send by email to the school contact person listed for the relevant VET program. (www.fmpllen.com.au)
- Payment of an application deposit may be required by your own school.
- The initial closing date for applications are yet to be confirmed, although early applications are encouraged.

The application form is not a guaranteed enrolment.

Once classes are finalised, each student may need to complete an additional enrolment document or additional application forms or online applications as required by the relevant RTO's or TAFE.

There may be vacancies after the initial deadline but that will be dependent on numbers.

We provide the skills, knowledge and attitudes for training in acting for Film and Television.

VET Acting is delivered to Year 10, 11 and 12 students who are passionate about this specialised subject. The units of competency are designed to give a common sense approach to learning.

- · Filming in front of camera
- Confidence and communication builder
- Skills proficiency in interviewing, auditioning and screen-testing
- Develop digital skills that will ensure relevance and transferability to industry
- Production of a film project using the UOC electives needed in the second year
- Training caters for VCE, VCE-VM students

Contribution to VCE/VCE-VM:

Credit towards VCE, VCE VM, VPC and Intermediate VCAL. It is recommended that students have literacy and numeracy competencies equivalent to ACSF Level 2 and AQF Level 3, suitable to undertake a Certificate III. This certificate provides the minimum 180 hours required to achieve two units towards VCE and two VCE VET Credits in the VM, also providing 2 credits towards the VPC. Please note the minimum VET requirement for the VPC is one credit = 90 hours. VCE: On completion students will receive recognition of two units at Unit 1 and 2 and a Unit 3 and 4 sequence ATAR: Scored assessment is available for Unit 3 and 4 of this course. Students who undertake additional training can achieve a further Units 3 and 4 sequence and may be eligible for an increment.
